To discuss Bruton Community Partnership (BCP)'s decision of 11 June 2020 to transform itself into a new Community Interest Company (CIC), what representation Bruton Town Council should request on this new body and make any other observations.

Members of Committee are advised that they should consider these matters in the exercise of their functions: Equal opportunities (race, gender, sexual orientation, marital status and any disability): Crime and Disorder, Health and Safety and Human Rights. **Background Information:** a new CIC called "Bruton for Bruton CIC" will be created as a successor body to BCP, with objects similar in principle to those of BCP; BCP will transfer its assets to the new CIC; the existing BCP partnership will be dissolved on the creation of the new body; and GF, DW and JH are delegated to liaise with CRLW on implementing this decision (keeping the Committee and BTC informed).

# 8. Bruton Food Drop

### 9. Council Funding Contribution to The Dove

Full Council 30 June 2020 agreed that this matter be further discussed with The Dove prior to consideration by F&GP Committee on 21 July 202.
